Molecular Weight:	Approximately 7.9 kDa, 69 amino acid residues.
Source:	Recombinant rat RANTES (regulated upon activation, normal T cell expressed and secreted) is produced in <i>E. coli</i> .
Purity:	Recombinant rat RANTES is >98% pure by SDS-PAGE and HPLC analyses.
Biological Activity:	Biological activity of recombinant rat RANTES is determined by measuring concentration dependent chemotaxis with rat peritoneal macrophages. A concentration range of 50–100 ng/mL produces significant chemotaxis. The optimal concentration should be determined for each specific application.
Formulation:	Lyophilized, carrier-free. Sterile filtered prior to lyophilization.
Endotoxin:	Endotoxin level is <0.1 ng/µg of recombinant rat RANTES.
Reconstitution Recommendation:	We recommend that the vial be briefly centrifuged prior to opening to bring the contents to the bottom. Recombinant rat RANTES should be reconstituted in sterile distilled water to a concentration of 0.1–1.0 mg/mL. Further dilutions should be made in tissue culture grade buffered solutions with heat inactivated fetal calf serum or low endotoxin BSA.
Storage:	This lyophilized preparation is stable at 2°C to 8°C, but should be kept at –20°C for long term storage, preferably desiccated. Upon reconstitution, the preparation is stable for up to one week at 2°C to 8°C. For maximal stability, apportion the reconstituted preparation into working aliquots and store at –20°C. Avoid repeated freeze/thaw cycles.
