Biological Activity:	$ED_{50} = 5-10$ ng/mL, determined by the dose dependent stimulation of IL–8 production by human PBMCs. Please note that this biological activity may vary with each PBMC donor. The biological activity was also determined in a mouse splenocyte survival assay. The ED_{50} for this assay is 0.5–2.0 µg/mL. BAFF is a member of the TNF ligand superfamily, which serves as a costimulator of B cell proliferation and function. This recombinant protein corresponds to the TNF–like portion of BAFF's extracellular domain.
Formulation:	Lyophilized from 0.5x PBS, pH 7.5, with 0.5 mM DTT. Sterile filtered prior to lyophilization.
Endotoxin:	<0.1 ng/μg
Production:	Produced in E. coli and purified by sequential chromatography.
Reconstitution Recommendation:	We recommend that this vial be briefly centrifuged prior to opening to bring the contents to the bottom. Reconstitute in sterile, distilled water to a concentration of 0.1–1.0 mg/mL. <i>Do not vortex</i> . This solution can be stored at 2°C to 8°C for up to 1 week. For extended storage, it is recommended to further dilute in a buffer containing a carrier protein, such as 0.1% BSA and store in working aliquots at –20°C to –80°C.
Suggested Working Dilutions:	The optimal concentration should be determined for each specific application.
Storage:	The lyophilized protein is stable at room temperature for 1 month, but should be kept at -20° C for long term storage. Working aliquots stored with a carrier protein are stable for at least 3 months at -20° C to -80° C. Avoid repeated freeze/thaw cycles.
