

Recommended Assay Procedure:

ELISA Capture: The purified monoclonal antibody 3C7 (Cat. No. 555035) is useful as a capture antibody in a sandwich ELISA for measuring human eotaxin protein levels. Purified monoclonal antibody 3C7 can be paired with the biotinylated monoclonal antibody 10C11 (Cat. No. 555060) with recombinant human eotaxin (Cat. No. 555102) as the standard. Purified monoclonal antibody 3C7 should be titrated to determine its optimal concentration for ELISA capture (0.5 - 2.0 µg/ml). To obtain linear standard curves, doubling dilutions of recombinant human eotaxin (Cat. No. 555102) ranging from ~1,000 to 20 pg/ml are recommended for inclusion in each ELISA plate.
