

Description

The GoH3 monoclonal antibody specifically binds to CD49f or integrin α 6 chain, a 150 kDa transmembrane protein, member of extracellular matrix and cell adhesion receptor family. α 6 associates with integrin β 1 chain (CD29) to form VLA-6 and with integrin β 4 chain (CD104) to form the α 6 β 4 complex, also known as the laminin and kalinin receptor. CD49f is expressed mainly on T cells, monocytes, platelets, epithelial and endothelial cells, perineural cells and trophoblasts of placenta. GoH3 recognizes an extracellular epitope of integrin α 6 on human, mouse and bovine cells. GoH3 has been reported to block the binding of integrin α 6 to laminin P1 and E8 fragments.

No. 562475/562495; solid line histogram) or with a PerCP-Cy™5.5 Rat IgG2a, κ Isotype control (Cat. No. 550765, dashed line histogram). The erythrocytes were lysed with BD Pharm Lyse™ Lysing Buffer (Cat. No. 555899). The fluorescence histograms were derived from events with the forward and side light-scatter characteristics of viable lymphocytes. Flow cytometry was performed using a BD™ LSR II Flow Cytometer System.

Preparation and Storage

Store undiluted at 4°C and protected from prolonged exposure to light. Do not freeze.

The monoclonal antibody was purified from tissue culture supernatant or ascites by affinity chromatography.

The antibody was conjugated with PerCP-Cy5.5 under optimum conditions, and unconjugated antibody and free PerCP-Cy5.5 were removed. Storage of PerCP-Cy5.5 conjugates in unoptimized diluent is not recommended and may result in loss of signal intensity.
