

Description

The RPA-T8 monoclonal antibody specifically binds to CD8 alpha (CD8 α). CD8 α is a type I transmembrane glycoprotein and a member of the immunoglobulin superfamily. CD8 α is expressed by the majority of thymocytes, by subpopulations of $\alpha\beta$ T cells and $\gamma\delta$ T cells and by some NK cells. Cell surface CD8 α is expressed either as a disulfide-linked homodimer (CD8 $\alpha\alpha$) or as a heterodimer (CD8 $\alpha\beta$) when disulfide-bonded to a CD8 beta chain (CD8 β). CD8-positive $\alpha\beta$ T cells coexpress both CD8 $\alpha\alpha$ homodimers and CD8 $\alpha\beta$ heterodimers whereas some $\gamma\delta$ T cells and NK cells express CD8 $\alpha\alpha$ homodimers. CD8 plays important roles in T cell activation and selection. The extracellular IgSF domain of CD8 α binds to a non-polymorphic determinant on HLA class I molecules (α 3 domain) and enables CD8 to function as a co-receptor with MHC class I-restricted TCR during T cell recognition of antigen. The cytoplasmic domain of CD8 α associates with Lck, a Src family protein tyrosine kinase that is involved in intracellular signaling. The RPA-T8 and HIT8a (Cat. No. 555337) monoclonal antibodies are not cross-blocking.

The antibody was conjugated to BD Horizon[™] BV510 which is part of the BD Horizon[™] Brilliant Violet[™] family of dyes. With an Ex Max of 405-nm and Em Max at 510-nm, BD Horizon[™] BV510 can be excited by the violet laser and detected in the BD Horizon[™] V500 (525/50-nm) filter set. BD Horizon[™] BV510 conjugates are useful for the detection of dim markers off the violet laser.



Flow cytometric analysis of CD8α expression on human peripheral blood lymphocytes. Human whole blood was stained with the BD Horizon™ BV510 Mouse Anti-Human CD8 antibody (Cat. No. 563256; solid line histogram) or with BD Horizon™ BV510 Mouse IgG1, κ Isotype Control (Cat. No. 562946; dashed line histogram). The erythrocytes were lysed with BD Pharm Lyse™ Lysing Buffer (Cat. No. 555899). The fluorescence histograms were derived from events with the forward and side light-scatter characteristics of viable lymphocytes. Flow cytometric analysis was performed using a BD™ LSR II Flow Cytometer System.

Preparation and Storage

Store undiluted at 4°C and protected from prolonged exposure to light. Do not freeze.

The monoclonal antibody was purified from tissue culture supernatant or ascites by affinity chromatography.

The antibody was conjugated with BD Horizon[™] BV510 under optimum conditions, and unconjugated antibody and free BD Horizon[™] BV510 were removed.
