## **Product Description**

Interleukin 8 (IL-8) is a pro-inflammatory factor belonging to the C-X-C subfamily of chemokines. It functions as a chemoattractant and a potent angiogenic factor. The expression and secretion of IL-8 can be induced by diverse inflammatory stimuli in many cells, including macrophages and storage vesicles (Weibel-Palade bodies) of endothelial cells.



Western blot analysis was performed on the recombinant protein and detected at ~8.9 kDa using ABfinity  $^{\text{TM}}$  IL-8 Recombinant Rabbit Monoclonal Antibody at a concentration of 2  $\mu$ g/mL. The blot was developed using enhanced chemiluminescence (ECL) method.

### Storage Buffer

Phosphate buffered saline (PBS) with 0.09% sodium azide.




Figure 2 Indirect ELISA of ABfinity™ IL-8 Recombinant Rabbit Monoclonal Antibody (Cat. no. 701232).

Indirect ELISA was performed using various dilutions of ABfinity<sup>™</sup> IL-8 Recombinant Rabbit Monoclonal Antibody to detect IL-8 recombinant protein coated onto the plate. A nonlinear regression analysis was performed (4 PL), and LOD and LOQ for the antibody was determined.
