Product Description

Interleukin 4 (IL-4) is a member of the glycoprotein growth factor family of cytokines which regulate hematopoiesis. It induces the differentiation of naive helper T cells to Th2 cells, and also stimulates growth, differentiation, and activation of B cells, and acts as a growth factor for T cells and mast cells. It induces proliferation of T lymphocytes, and inhibition of apoptosis and immunoglobulin class switching in B cells.

When stored as instructed, expires one year from date of receipt unless otherwise indicated on product label.




Figure 1 Western blot analysis of IL-4 (Ms) ABfinity[™] Recombinant Rabbit Oligoclonal Antibody (Cat. no. 710254).

Western blot analysis was performed on IL-4 mouse recombinant protein. An endogenous level of IL-4 was detected at ~14 kDa using ABfinity $^{\mbox{\tiny TM}}$ IL-4 (Ms) Recombinant Rabbit Oligoclonal Antibody at a concentration of 2 µg/mL. The blot was developed using enhanced chemiluminescence (ECL) method.

Storage Buffer




Figure 2 Indirect ELISA of ABfinity[™] IL-4 (Ms) Recombinant Rabbit Oligoclonal Antibody (Cat. no. 710254).

Indirect ELISA was performed using various dilutions of ABfinity[™] IL-4 (Ms) Recombinant Rabbit Oligoclonal Antibody to detect IL-4 (Ms) recombinant protein coated onto the plate. A non-linear regression analysis was performed (4 PL), and LOD and LOQ for the antibody was determined.
