# **Product description**

Fibrinogen is a soluble protein found in blood plasma and is produced by the liver cells. The protein is a hexamer consisting of two sets of disulfide linked chains (alpha, beta, and gamma). Fibrinogen is essential for blood coagulation as the precursor of fibrin. It is converted to fibrin by the action of thrombin in the presence of calcium ions.

When stored as instructed, expires one year from date of receipt unless otherwise indicated on product label.






Figure 1 Western blot analysis of ABfinity™ Fibrinogen Recombinant Rabbit Oligoclonal Antibody (Cat. no. 710386).

Western blot analysis was performed on recombiant protein. Endogenous level of Fibrinogen was detected at ~340 kDa using ABfinity™ Fibrinogen Oligoclonal Antibody at a concentration of 1 µg/mL, followed by Goat Anti-Rabbit HRP (Cat. no. G21234) as a secondary antibody. The blot was developed using enhanced chemiluminescence (ECL) method.

## Storage buffer

Phosphate buffered saline (PBS) with 0.09% sodium azide.




Figure 2 Indirect ELISA of ABfinity™ Fibrinogen Recombinant Rabbit Oligoclonal Antibody (Cat. no. 710386).

Various dilutions of ABfinity™ Fibrinogen Recombinant Rabbit Oligoclonal Antibody were used, followed by Goat Anti-Rabbit HRP (Cat. no. G21234). A non-linear regression analysis was performed [4 PL], LOD, and LOQ for the antibody was determined.




Figure 3 Indirect ELISA of ABfinity™ Fibrinogen Recombinant Rabbit Oligoclonal Antibody (Cat. no. 710386).
