#### **Product Description**

Sonic Hedgehog (SHH) is a secreted signaling protein belonging to Hedgehog family. It plays an important role in patterning and organogenesis during embryonic development. In adult cells, SHH plays a role in control of cell division. The hedgehog signalling pathway is initiated when SHH binds the Patched receptor (PTC) resulting in release of SMO from repression. SMO acts to inhibit proteolytic cleavage of the Ci protein which acts as a transcriptional activator.

When stored as instructed, expires one year from date of receipt unless otherwise indicated on product label.




Figure 1 Western blot analysis of ABfinity™ SHH Recombinant Rabbit Oligoclonal Antibody (Cat. no. 710410).

Western blot analysis was performed on whole tissue extracts from rat brain and whole extracts of HepG2 lysate. Endogenous level of SHH was detected at  $\sim\!50$  kDa using ABfinity  $^{\!\top\!\!}$  SHH Recombinant Rabbit Oligoclonal Antibody at a concentration of  $2\mu g/mL$ . The blot was developed using enhanced chemiluminescence (ECL) method.

## Storage Buffer

Phosphate buffered saline (PBS) with 0.09% sodium azide.




Figure 2 Indirect ELISA of ABfinity™ SHH Recombinant Rabbit Oliqoclonal Antibody (Cat. no. 710410).

Indirect ELISA was performed using various dilutions of ABfinity™ SHH Recombinant Rabbit Oligoclonal Antibody to detect SHH peptide coated onto the plate. A non-linear regression analysis was performed (4 PL), LOD, and LOQ for the antibody was determined.




Figure 3 Immunocytochemistry analysis of ABfinity™ SHH Recombinant Rabbit Oligoclonal Antibody (Cat. no. 710410).
