## Product Description

Nrf2 (nuclear factor erythroid 2-related factor 2) is a transcription activator which plays a key role in protecting the cell from oxidative stress and inflammation. It is primarily localized in the cytoplasm under normal conditions, but under conditions of oxidative stress, Nrf2 migrates to the nucleus to upregulate expression of genes with ARE (antioxidant response elements) in the promoter region. The upregulated genes include those involved in cellular protection, drug transport, detoxification, and anti-oxidant defense. The protein is ubiquitously expressed in various tissues, with the highest levels found in kidney, muscle, lung, heart, liver, and brain.

When stored as instructed, expires one year from date of receipt unless otherwise indicated on product label.

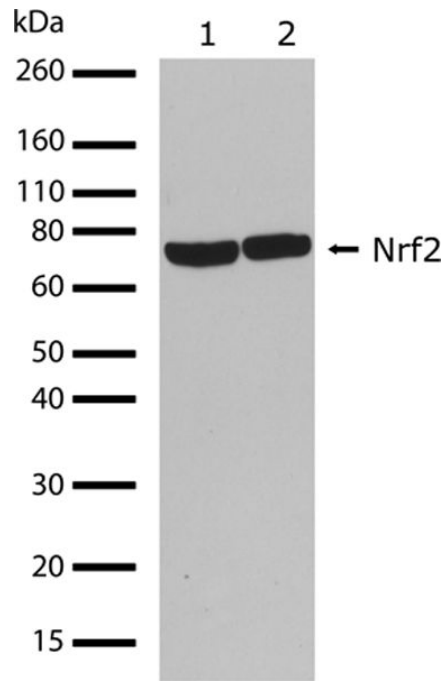


Figure 1 Western blot analysis of ABfinity™ Nrf2 Recombinant Rabbit Oligoclonal Antibody [Cat. no. 710574].

Western blot analysis was performed on whole extracts of U2OS and HeLa cells (Lanes 1-3 respectively). U2Os cells were treated with TBHQ (200µM for 3hr), and HeLa cells were treated with Menadione (100µM for 1hr). Endogenous level of Nrf2 was detected at ~68 kDa using ABfinity™ Nrf2 Recombinant Rabbit Oligoclonal Antibody at a concentration of 0.5 µg/mL, followed by Goat Anti-Rabbit HRP (Cat. no. G21234) as a secondary antibody. The blot was developed using enhanced chemiluminescence (ECL) method.

## Storage buffer

Phosphate buffered saline (PBS) with 0.09% sodium azide.

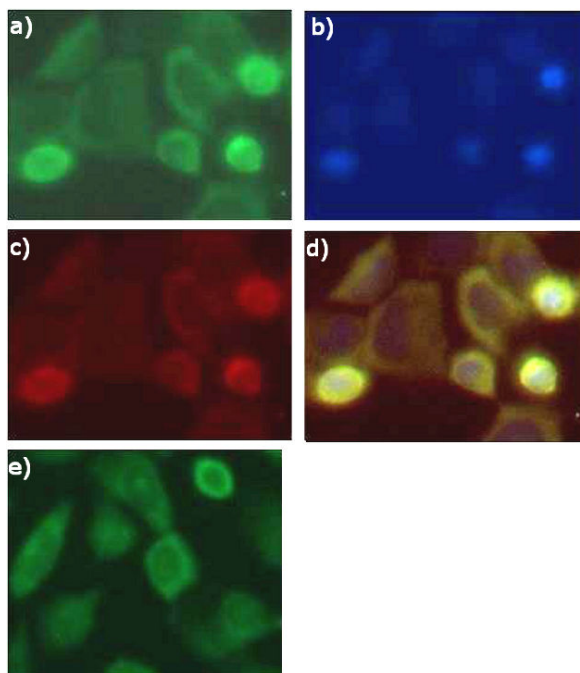


Figure 2 Immunocytochemistry analysis of Nrf2 ABfinity™ Recombinant Rabbit Oligoclonal Antibody (Cat. no. 710574).
